- All amounts due will be made payable to the Grand Island Chamber of Commerce as follows. For amounts of \$400 or less, payment in full with advertising agreement. For amounts over \$400, minimum 50% deposit with advertising agreement and balance due with accepted proof.
- Chamber of Commerce members in good standing as of the date of this agreement are eligible for member advertising rates. All others will be invoiced at the non-member rates.
- Grand Island Chamber of Commerce will try to accommodate requested ad position as closely as possible with no guarantee.
- This advertising agreement is non-cancellable by advertiser and advertiser fully understands all terms herein.
- 6. Advertiser agrees to adhere to ad submission deadline date. Failure by advertiser to respond to copy proof by deadline date shall be construed as advertiser's permission for Chamber of Commerce to print ad copy as shown on proof and any monies for balance of ad cost shall become immediately due and payable by advertiser to the Chamber of Commerce.
- 7. Advertiser guarantees payment of all charges for services rendered by the Grand Island Chamber of Commerce.
